I acknowledge that the CHILDREN’S EDUCATIONAL FOUNDATION, MY*TRI AND MILLER’S LANDING RESORT and all associated events that I have signed up for and will participate in is a test of a person’s physical and mental abilities and may carry with it the potential for death, serious injury and property loss.
